Ridgewood Terrace Health and Rehabilitation Center is located off the Pennyrile Parkway (Exit 44) at 425 Island Ford Road in Madisonville, Kentucky. This beautifully decorated facility offers private and semi-private rooms with a view of landscaped grounds and courtyard. Accommodations are available for fulltime residents and for those needing a short-term stay.

Specialized in-house rehabilitation services including speech therapy, physical therapy and occupational therapy, are provided by Evergreen Rehabilitation. *Ridgewood Terrace Health and Rehabilitation Center* is also licensed to offer orthopedic services including therapy for fractures, post-op individuals, and those needing prosthesis.



Hairdresser and barber services are offered weekly. A registered dietitian is on staff to ensure residents' nutritional needs are met. Doctors of Optometry and Podiatry are on call to assist residents. A registered pharmacist monitors all medications to ensure proper protocol is followed when medicines are ordered, delivered, and dispensed. All services are periodically evaluated so as to enhance the life of the resident.

Families and friends of the residents serve on the Family Council and assist the Admissions Coordinator in dealing with issues and concerns which affect resident care. Membership is encouraged.
